# **Goal 3: Funding housing**

Financially support the development and preservation of safe, stable, affordable housing in Polk County. Work towards a region that has a range of housing options promoting housing choice.

- 1. Create and clearly communicate PCHTF's HAP funding opportunities with public applications and set guidelines for each opportunity.
- 1.A. Create Neighborly Applications for each HAP funding opportunity
- 1.B. Implement the utilization of Neighborly software for all PCHTF development activities
- Establish a set of Summarized Development Guidelines for all PCHTF Development funding
- 2. Respond to affordable housing needs in the community by creating our annual funding plan and assessing its impact.
- 2.A. Create annual Housing Allocation Plan (HAP)
- 2.B. Award, Disperse, and Contract annual Housing Allocation Plan funds
- 2.C. Work to prioritize higher density projects funded with Trust Fund dollars
- 2.D. Promote housing strategies for extremely low income (30% AMI) or very low income (50%) unit creation
- 2.E. Work to grow annual PCHTF financial investments in housing

- 3. Emphasize repayable loans as standard award process for new rental round of funding
- 3.A. Seek additional investment partners
- 3.B. Explore fee for service opportunities

- By dispersing/committing funds from our annual Housing Allocation Plan (HAP)
- By prioritizing PCHTF's funding for housing in mixed-income developments
- An increase in affordable housing projects built in neighborhoods that lack adequate housing variety
